TRANSITION

It is with profound gratitude to so many of you that I write this final report to the Faculty Senate. I officially end my position as Provost at The University of Scranton on June 1. While I am tremendously excited for the next steps of my journey at St. Bonaventure University, I have truly come to love the University of Scranton community and mission. I am grateful to the all of our faculty for their support and their steadfast commitment to our students, especially through the COVID-19 pandemic.

The Provost's Office will be in good hands as Michelle Gonzalez Maldonado, Ph.D., currently Dean of the College of Arts and Sciences, has agreed to serve as Interim Provost and Senior Vice President for Academic Affairs for the 2022-2023 academic year, while the University conducts a national search for the permanent position. I look forward to working with Michelle over the next month to ensure a smooth transition. She brings much experience and mission background to this position.

I am also pleased with the new Dean team that will be in place next year:

- Victoria Castellanos, Ph.D., will serve as the Dean of the Panuska College of Professional Studies. Dr. Castellanos has been the Interim Dean of PCPS since January of this year, having served as Associate Dean of PCPS since joining our community in 2012.
- Mark Higgins, Ph.D., will join us as Dean of the Kania School of Management on July 1. Dr. Higgins comes to us from our sister Jesuit school, St. Louis University, where he serves as a professor of accounting and, from 2015 to 2019, was Edward Jones Dean and Professor of Accounting at their Richard A. Chaifetz School of Business.
- George Aulisio has accepted the position of Dean of the Weinberg Memorial Library.
 Dean Aulisio has been serving as the interim dean since July 1, 2021 and assumed the permanent position in early March 2022. He was previously the Chair of our Library Faculty Department and Full Professor at the University.
- David Dzurec, Ph.D., will serve as interim Dean of the College of Arts and Sciences, while Dr. Maldonado serves as interim Provost. Dr. Dzurec is currently the Associate Dean of Arts and Sciences and Full Professor of History.

DISCONTINUATION OF THE LAWS DEPARTMENT

The Latin American Studies and Women's and Gender Studies department will be discontinued beginning in the 2022-2023 academic year. This decision was initiated by the request of the faculty within the department.

A thoughtful process between faculty and administration led to this decision. The CAS Dean (Michelle Maldonado) and directors of Women's and Gender Studies, Asian Studies and Latin American Studies met to discuss the idea of merging the three programs under only one director. All directors shared with Dean Maldonado their concerns on this possibility. Latin American Studies (LAS) members during their full faculty meeting began a conversation on removing LAS from LA/W/S. All members agreed on the importance of continuing to have a director that represents the interest of their program, works on increasing numbers, and makes stronger concentrations throughout the University. Women's and Gender Studies (WGS) members had a similar conversation and came to the same conclusions. WGS and LAS directors then met again with Dean Maldonado and agreed to discontinue LAWS as a department and the positions of chair.

The two programs of LAS and WGS will continue to exist unchanged: specifically, LAS and WGS will maintain their major and concentration, and next year will keep two separate directors, office spaces, a secretary, and funds to continue operating and for programming needs. In a parallel model to Asian Studies, the two Programs will report directly to the CAS Dean.

FULBRIGHT UPDATE

Dr. Michael Bermudez, Assistant Professor in Occupational Therapy has been selected as a Fulbright U.S. Scholar for 2022-2023. He will be working at the Faculty of Special Needs and Rehabilitation at Kyambogo University in Kampala, Uganda.

Two of our five national finalists have been notified that they were awarded a Fulbright Scholarship and one student has been named an alternate.

- Crysta O'Connell, a double major in International Studies and Hispanic Studies with a minor in French has been selected to receive an English Teaching Assistantship to Andorra.
- Peter Amicucci majoring in Operations Management with minors in Mathematics and Business Analytics will pursue an MS in Economics and Business with a concentration in Supply Management at the Lappeenranta University of Technology in Finland.
- Sarah White a Presidential Scholar, and a double major in Biology and Philosophy with a minor in Mathematics is an alternate for a grant to conduct research in Denmark and Greenland.

PLANNING & INSTITUTIONAL EFFECTIVENESS

University-wide efforts to implement our 2020 Strategic Plan continue. In addition to work underway through divisional, college, and departmental planning, a key focal area for the plan's first full year was the successful development of the new Diversity, Equity, and Inclusion Plan. Over the summer and fall, we will be engaged in the development of a new campus-wide plan for Sustainability, to expand and enhance the institutional scope of that aspect of our plan, and the "care of our common home."

In early April, academic department chairs and administrative department, college, and divisional leaders received instructions for their participation in this year's Annual Planning and Reporting cycle. It is through this process that departments outline their own goals, report progress on that work, identify longer-term planning opportunities and challenges, document and describe learning and institutional assessment outcomes and their application, and submit resource requests. In each of these fields, alignment with the University's strategic plan and/or institutional learning outcomes is described. New this year is a focused reflection space for those submitting reports to describe how they are supporting, or plan to support, the new DEI plan.

Information submitted in Annual Reports is used to inform Strategic Plan progress reporting. The strategic plan web site includes a section describing plan progress to date, noting significant

achievements, work underway, and selected performance indicators. As described by the Strategic Plan Implementation Roadmap, the report will be updated on a regular basis to capture our progression of work at key intervals; the next update will include reflection on data from student and other surveys underway this academic year, including the National Survey of Student Engagement (NSSE). Over the spring months, the Middle States Commission on Higher Education (MSCHE) has been undertaking a review of its *Requirements for Affiliation and Standards for Accreditation*. We anticipate updated Requirements and Standards to be in place this summer. These new documents will guide out institutional accreditation efforts for the years ahead, including our preparations for the University's next MSCHE review, scheduled for 2027-2028.

OFFICE OF RESEARCH AND SPONSORED PROGRAMS

The Office of Research and Sponsored Programs held its 22nd Annual Celebration of Student Scholars on April 27, 2022. This event celebrated both undergraduate and graduate student scholarship. Student scholarly work includes thesis research, research conducted as part of the Faculty/Student Research Program or resulting from a President's Fellowship for Summer Research, and research or other scholarly projects carried out as independent study.

ACCREDITATION UPDATE

The online Master of Science in Health Informatics has received accreditation from the Commission on Accreditation for Health Informatics and Information Management.

- The Master of Science Education Program in Speech-Language Pathology is an applicant for candidacy by the Council on Academic Accreditation in Audiology and Speech-Language Pathology of the American Speech-Language-Hearing Association. Anticipated to enroll its first class in the fall of 2023.
- The Nursing Department had site visits from their two accrediting bodies, Commission on Collegiate Nursing Education and the Council on Accreditation of Nurse Anesthesia Educational Programs in March and April 2022. Decisions regarding reaccreditation are expected in fall 2022.

UPDATES

- On Friday, May 13th the Library will be hosting a special event to kick off the Library's 30th Anniversary celebration. Dean Emeritus Charles E. Kratz, Jr. will be honored at the ceremony.
- CAS will launch a revision of Academic Advising in the College this summer to provide students a more consistent and cohesive advising experience. An emphasis on academic vocation and experiential learning. A capstone experience will be developed for all CAS students that focuses on Jesuit and Catholic education and Ignatian values.

- The CAS Dean's Office is collaborating with the Council of Alumni Lawyers and Development to create an internship program and database similar to the shadowing program developed in collaboration with our Medical Alumni.
- The CAS dean convened a working group to assess Global Studies within the College. Recommendations of the International Studies Major: review curriculum; addition of study abroad or internship requirement; move the program from History to bridge both History and International Studies (similar to the Neuroscience model which bridges Psychology and Biology)
- The Library's University Archives will host an exhibit of faculty scholarship in May and the second exhibit of books published by alumni in June and July.
