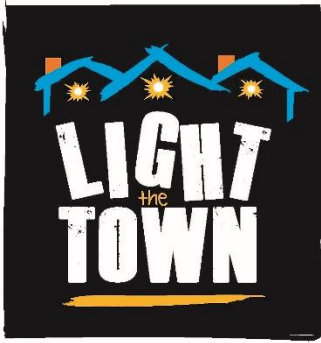

LIGHT THE TOWN PROPERTY OWNER AGREEMENT

Each homeowner participating in the "LIGHT THE TOWN" Project must sign the below waiver and release.

I affirm that I am the sole and lawful owner of the home described below, and that I have the authority to participate in NeighborWorks Northeastern Pennsylvania "Light the Town" Project. By signing below, I hereby give my permission for NeighborWorks Northeastern Pennsylvania to install a solar security light on my home.

I understand that NeighborWorks Northeastern Pennsylvania and its employees, agents or volunteers are installing the exterior solar light fixture free of charge for the benefit of my home and the safety of my neighborhood. In consideration of the work to be performed for my benefit, I agree to maintain the solar security light fixture by cleaning it periodically in order to optimize its operation.

Further, I understand that there is no guarantee that all of the scheduled work will be completed by NeighborWorks Northeastern Pennsylvania and its employees, agents or volunteers. I hereby authorize them to enter my property in order to complete the installation. In consideration of the work to be performed free of charge by NeighborWorks Northeastern Pennsylvania and its volunteers.

I further agree to accept the work performed in an "as is" condition, and I hereby irrevocably absolve, release and waive any and all liability, actions, claims or demands against NeighborWorks Northeastern Pennsylvania, its directors and officers, employees, agents and volunteers for any losses sustained on the premises or as a result of, or in connection with, any work performed on my home, whether such work is intended or authorized. Without limiting the generality of the foregoing, I agree that this waiver and release shall include any and all manner of actions, suits, debts, accounts, direct and indirect damages, judgments, demands or causes of action whatsoever in law or equity, or otherwise, resulting from any loss, theft, personal injury or damage my home sustained in connection with any work performed by NeighborWorks Northeastern Pennsylvania or its volunteers.
