We are glad you are considering the University as your academic home for the next few years. We appreciate the chance to share a little about our recent accomplishments.

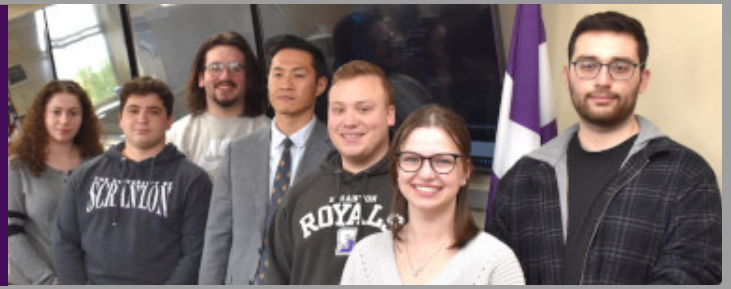
But first, here are a few things that distinguish us from other types of similar academic institutions and programs:

- We have a flexible curriculum that allows students to take advantage of multiple outstanding internship opportunities for credit and encourages them to complete a minor or double major.
- We collaborate with the University's Chemistry Department (Forensic Chemistry major) and Business School (Forensic Accounting track and Business 5yr BS/MS program).
- Our faculty are recognized nationally and internationally in their various professional organizations and also have relevant experience in the field.
- We have an active Criminal Justice Student Club that regularly brings in speakers, coordinates off-campus trips, and engages in community service and we have recently started a chapter—Omega Sigma Alpha—of the American Criminal Justice Association.
- We are one of only nine criminal justice undergraduate programs in the United States to obtain certification from the Academy of Criminal Justice Sciences (ACJS).
- Our Center for the Analysis & Prevention of Crime (CAPoC) combines faculty expertise, practitioner insight, and student learning to enhance the technological and analytical capabilities of students, police officers, and other criminal justice and social service agencies in the regional community.
- We are a Catholic and Jesuit University that is based on a 450 year-old intellectual tradition that strives for excellence and cares for each and every student.

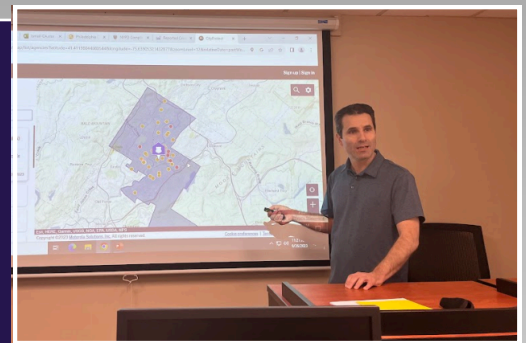

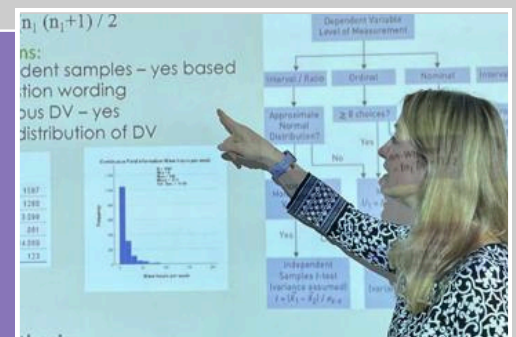

## DEPARTMENT NEWS



This upcoming Fall, we will be in our new building that will include three labs for crime analysis/research, cyber attack simulation, and cyber forensics and a mock crime scene for traditional investigations. There will also be rooftop reflection space, a prayer room, and space for the mock trial team to practice.

The faculty are planning a study abroad summer course for June 2025, titled "Global Crime, Justice, & Security in Spain." This travel course explores the concepts of justice, security, and crime, covering topics such as global justice standards, international law, and transnational crime. As part of the program, students will visit key Spanish criminal justice institutions in Madrid, including the Spanish National Police, the Prosecutor's Office, and the Ministry of Justice. Additionally, students will have the opportunity to participate in a Cybercrime Investigation Competition at the International White Hat Conference in León, Spain.



**Dr. Ismail Onat** published an article based on his research using data from the Atlantic City Police Department. He analyzed the association between mental health related calls and the crisis intervention training. In another publication, Dr. Onat led the research on terrorist arson in urban places and published a journal article with his colleagues from two other universities.

**Dr. Michael Jenkins** traveled to El Salvador on a mission-based educational pilgrimage to learn about the Jesuit martyrs and life in El Salvador in the aftermath of the civil war. It was a transformational experience that shed light on the importance of Jesuit higher education in the world and the complicated issues of immigration, state violence, gangs, and crime in the US and in El Salvador.



**Dr. Mehmet Bastug** received the 2024 Faculty Senate Excellence in Graduate Teaching Award for his outstanding contributions to teaching in the Cybercrime Investigation and Cybersecurity Master of Science program. He co-authored an encyclopedia entry titled "Cyberterrorism" with **Dr. Onat** for the Oxford Research Encyclopedia of Criminology and Criminal Justice. Dr. Bastug's recent peer-reviewed journal articles have been published in several reputable journals and conference proceedings, including the Proceedings of the IEEE International Conference on Computational Science and Computational Intelligence (CSCI), the Journal of Policing, Intelligence, and Counter Terrorism, Behavioral Sciences of Terrorism and Political Aggression, and Terrorism and Political Violence. Additionally, he has renewed his Certified Ethical Hacker (CEH) certification for another three years.

**Dr. Sinchul Back**, the Director of Cybercrime Studies, published an article on AI-assisted facial recognition, titled "AI-Powered Facial Recognition Training in Higher Education." The study examines how advanced facial and image recognition technologies can be integrated into higher education programs to better prepare future law enforcement professionals in the United States. Lastly, to incorporate drone operation and forensics into his technical courses, Dr. Back recently earned a Remote Pilot Certificate from the Federal Aviation Administration (FAA).

In collaboration with his colleagues, Dr. Back will host the 5th Royal's Cyber Investigation Camp for area high school students from July 8-10, 2025. The camp, will be held in the University's Cyber Forensics Lab, and will introduce students to AI & Robotics Investigation through hands-on training and interactive lessons.

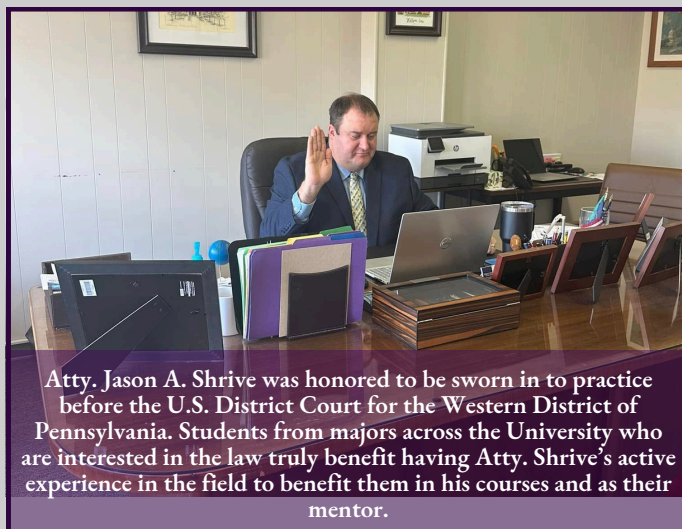
