SUBJECT: Academic Affairs Report for May 2025 (Revised)

1. PROVOST UPDATES

• The Artificial Intelligence draft policy received in-person and survey feedback. It was vetted at Cabinet April 8 and the UGC (University Governance Committee) on April 10. The presidents of the Student, Staff, and Faculty senates were to bring it to their constituents and submit an electronic vote back to UGC by May 15.

- Dr. George Aulisio, Dean of the Library, will be supervising the Director of the Innovation, Design, Education, and Application Center (IDEA Center) in Weiss Hall. A position description has been submitted to HR.
- Collaborative work across enrollment, student life, and academics on the Retention
 Working Group has led to many intentional interventions this spring. We will be taking a
 list of identified areas for improvement and gaps into a retreat after commencement. We
 will create prioritizations and time frames for quick, short term (12-18 months), and longterm initiatives. Where appropriate, working groups will be formed.

2. SEARCHES UPDATES

• Provost/Senior Vice President of Academic Affairs

The process of identifying our next Provost/Senior Vice President for Academic Affairs has begun. The consulting firm was on campus the week of April 28th and had listening sessions with multiple constituent groups. The position will be advertised nationally in late June/early July.

• Associate Provost

Dr. David E. Marx announced his intention to retire after 38 years of service, on July1. Faculty have been elected to serve on the search committee. Fr. Marina has appointed Liz Garcia (Chair) and Carolyn Berry to represent administration. Staff Senate leadership have put out a call for two professional staff representatives. The job description should be posted the week of May 5.

• CAS Associate Dean

The Search Committee chair for the reconfigured CAS Associate Dean position has reviewed applications and invited 3 candidates to come for on-campus interviews. We hope to have the interviews concluded by May.

3. STRATEGIC PLANNING UPDATE FOR THE BOARD OF TRUSTEES: MAY 2025

The University Planning Committee (UPC) is continuing to develop our next University-wide strategic plan. Several important milestones are moving forward.

Review of campus input and identification of emerging potential strategic directions.

Priorities previously identified from campus-wide input include: renewed emphasis on *civic*, *civil and ethical learning*, *engagement*, *and leadership*; student *access*, *enrollment*, *and success*; dedicated focus on *graduate*, *distance*, *international and other learner populations*, whose pathways and needs differ from our traditional undergraduate model; mission-oriented, sustained support for institutional planning in the areas of *diversity*, *equity*, *and inclusion*, *and sustainability*; *belonging*, *resilience*, *and wellness*, including mental health, for students, faculty, and staff; and expansion of *community- oriented programming and services* in line with Weiss Hall. Across all of these areas, members of the University community have repeatedly emphasized the need to appropriate resource our planning activities, and to improve collaboration, transparency, and cross-departmental communication, and reduce procedural barriers that may limit our ability to meet our goals. The UPC has been mindful of these issues in considering the new plan, and also in its discussions about nearer-term priorities under the current plan (more on this below).

The UPC will hold a retreat later this month to discuss and discern amongst these potential priorities and prepare an initial full draft strategic plan that will outline specific intended outcomes, resource implications/needs, and other operational stewardship details. We anticipate sharing a draft strategic plan with the campus community in early fall, and the new plan launching in early 2026.

Sustained efforts on the current Strategic Plan, supporting transition to the next.

The priorities identified by the UPC this spring are detailed below. The Office of Planning & Institutional Effectiveness is working with campus leadership to coordinate and document the work done in each of these areas, and crosswalk activities to relevant areas in the new strategic plan draft. Progress in these areas will provide valuable evidence in preparing for our upcoming Middle States Self-Study and AJCU Mission Priority Examen.

Revised University Vision Statement.

A strategic planning process is a natural moment to engage members of our community in developing a fresh, future-oriented shared vision for the future, a need emphasized throughout our campus input sessions. Considering how much our community has changed over recent years and the extraordinary challenges facing higher education, there is now perhaps even greater importance in coming together in support of an inspirational University-wide vision. To undertake this project, the UPC formed a subcommittee to develop and propose a potential new vision statement. This draft statement will be shared with the University community as part of a broader strategic planning update prior to the close of the semester and will then be refined and included in the draft strategic plan package slated for community review in early fall.

Next steps

The Strategic Plan 2025 timeline outlines upcoming milestones in this process. The University my.scranton platform and www.scranton.edu/strategicplanning2025 web site will be important

information sharing vehicles to keep members of the University community apprised of progress. In addition to planned discussion with the Board in early fall, we welcome additional input.
